Also present: Ron Janzen, Scott Stuber, Heath Gilkes, Dave Amundson, Ruth Amundson, Craig Buros, Cheryl Bean, and Misty Bean.

Motion by Jelinek, seconded by Helseth, to accept the minutes from the July 7, 2020, council meeting as typewritten. Roll call, all aye, motion carried.

Motion by Jacobson, seconded by Rognstad, to suspend the rules & regulations to pay the accounts & claims. Roll call, all aye, motion carried.

Motion by Kurth, seconded by Hendrickson, to pay the accounts & claims. Roll call, all aye, motion carried.
